PROPOSED AGREEMENT WITH VERIZON NEW ENGLAND:

The Board reviewed the 2021 Annual Report.


Motion by Mr. Veaner, seconded by Ms. Hardin, to approve the BOA Annual Report for 2021. The motion passed unanimously.
