#### EAGLE SCOUT PROJECT PROPOSAL – JACKSON BARRY

Mr. Jackson Barry, age 16, a Millis resident and a Life Scout in Troup 76 in Holliston, presented his document entitled, "Outline of Jackson Barry Eagle Project," dated December 4, 2023. Mr. Barry would like to perform some trail clearing around the pond, provide public heath displays (kiosk) of information, and build walkways to supplement existing walkways at Richardson Pond.

The Commission discussed the proposed project and authorized the use of pressure treated lumber. The Commission will conduct a site visit/walk-through with Mr. Barry in the spring before any work is performed. Mr. Barry is hoping to receive project approval from the Boy Scout Mayflower Council by the end of February 2024. He will contact the Commission when he is ready for the site visit. Dr. Lederer signed Mr. Barry's form on behalf of the Conservation Commission.

# DEP FILE #CE225-0410; 66 MAIN ST. AND 12 & 16 MEADOW CARTWAY; TRESCA CERTIFICATE OF COMPLIANCE REQUEST

Ms. Fitzpatrick, representing Tresca Bros. Sand and Gravel, presented the Request for Certificate of Compliance. She stated that in September of 2017, the Commission issued an Order of Conditions for proposed work associated with sewer and water service for 12 & 16 Meadow Cartway and 66 Main Street. According to Ms. Fitzpatrick, the Order of Conditions has lapsed and the work was never started. She stated that the applicant "found a way to work around municipal sewer" and there are no plans in place to do the work in the future.

On a motion made by Mr. Steadman, seconded by Mr. Larsen, it was voted unanimously to approve a Certificate of Compliance, citing "Invalid Order of Conditions" as the work never commenced.

# NORFOLK COUNTY MOSQUITO CONTROL LETTER TANGERINI'S SPRING STREET FARM

The Commission discussed the letter from Norfolk County Mosquito Control, dated December 4, 2023, regarding "wetlands management activities" for property located within Tangerini's Farm. The Commission has no concerns/comments.

### 140 CAUSEWAY STREET – WINDY KNOB FARM, LLC "FOREST CUTTING PLAN"

The Commission reviewed the Forest Cutting Plan document prepared by John Clarke, Forester. The Commission also discussed the site visit they conducted with the property owner on Saturday, December 2, 2023.

A comment letter will be prepared and sent to Mr. Clarke, stating the following:

- 1. **Scenic Road Designation:** Causeway Street is designated as a Scenic Road in the Town of Millis. Therefore, the buffer zone is 100-feet rather than 50-feet.
- 2. **Forest Management Practices:** We commend the inclusion of sustainable forest management practices in the plan. However, we recommend a more detailed outline of how "temporary bridges" will be constructed. Where will staging areas for lumber be located? How wide will logging roads be and what type of equipment will be used for cutting?

Mr. Clarke will be asked to submit a revised plan and any additional documentation to the Commission.
